## Church Is Almost Destroyed By Fire

Baptist Congregation of South
Norfolk Lose Place of Worship—Will Build New Church
Meanwhile Worshipping in
Firemen's Hall.

Fire this morning at 6:15 o'clock practically destroyed the South Norfolk Baptist church, located at the corner of Chesapeake avenue and Gurrier streets, entailing a loss of between \$3,000 and \$4,000.

The blaze started in the Baraca-Philathea room in the northern and of the church nearest the Norfolk and Western Station. The origin of the fire is a mystery. The flames apread rapidly and the building was soon a

charred mass of ruins.

Mr. George White, who lives near the church, was the first to discover the fire and he hastily summoned the South Norfolk fire department. The firemen did excellent work in protecting other property, but were unable to save the church building which burned out on the interior and was left a shell, ready to topple in at any moment.

Some of the church furnishings, including the plane, were saved, but the pews are practically ruined. The church was partially covered by insurance.

### TO BUILD NEW CHURCH.

Rev. W. M. Black, paster of the church, said this morning that his congregation had in contemplation the erection of mew church edifice and had been raising funds for that purpose for some time, having already in hand \$2,200. He was to have held rally-day services in the church to-morrow, at which he expected to raise an additional amount for this purpose. These services will now be held at Firemen's Hall, which will be used by this congregation until the new church is completed.

The South Norfolk Baptist church was built more than ten years ago as a mission of the Berkley Avenue Baptist church and later run independent of that congregation. The church was enlarged during the pastorate of the Rev. Q. C. Davis. The church now has a membership of between six and seven hundred.

The residence of Thomas Black, adjoining the church, together with the furniture, was damaged to the extent of \$250.

### FIRE DESTROYS BAPTIST CHURCH

Congregation To Rebuild \$20,000 Brick And Stone
Structure

The South Norfolk Baptist church was totally destroyed by fire yesterday morning shortly after 6 o'clock entailing a loss of about \$4,000 with only \$1,500 insurance.

The fire was confined to the interior of the building and literally gutted it.

Te fire had its origin from an unknown source and the members, as well as pastor and deacons are at a loss to throw any light on the cause.

and most active member, who lives only a short distance from the church, which is located on Chesapeake avenue and Gurrier street, was the first person to discover the fire and called out the South Norfolk fire department which could do little more than hold the fire in subjection, preventing its spread to other valuable property in the community.

There was a rumor yesterday that a boy found a kerosene can in the building after the fire had been put out, but this could not be verified.

At a meeting of the board of deacons last evening it was decided to inaugurate plans at once with a view of constructing a \$20,000 brick and stone building on the site of the one destroyed.

The church has in hand \$2,200, which together with the insurance will give \$3,700 and with this it was decided to begin a campaign to raise \$10,000 for the initial payment on a new building. Plans and specifications will be drawn and submitted for bids.

The congregation will hold services today in Firemen's hall, South Norfolk, and will continue to occupy this building as a place of worship until other arrangements have been made.

All of the other churches of the community hastened to tender their houses in which to hold services until the homeless congregation can rebuild, for which the pastor, Rev. W. M. Black said yesterday that he is more than thankful.

The South Norfolk Baptist church was built more than twenty years ago as a mission under the supervision of the Berkley Avenue Baptist church. Under the pastorate of Rev. Q. C. Davis it was enlarged. It has a membership of about six hundred and a Sunday school of about five hundred members. The residence of Thomas Black, who was away at this time, was damaged to the extent of about \$250.

### FINED FOR VIOLATING SUNDAY LAW

C. C. Casper, colored, South Norfolk, was fined \$20 and costs by Magistrate Q. C. Davis of that place yesterday, charged with keeping his place open on Sunday and selling goods and was placed under bond of \$100 for one year. Casper was represented by Attorney I. W. Eason, who appealed to the Norfolk county Circuit Court.

The cash in hand was raised to \$2,400 yesterday, \$150 more being turned in by the several societies, and subscriptions were taken for \$1,700 at the morning service.

Mr. Black said last evening that they hope to raise the remainder of the ten thousand this week, , the amount which they desire to have in hand before a contract is let for the proposed new building.

Mr. Black may call on the sister churches of his congregation to help in the work of building a new edifice.

The attendance was large at all of the services yesterday and a deep interest manifested in the movement to build a new-and more auspicious home.
